1 Embedded Conditions Under the Local Government (Miscellaneous Provisions) Act 1982 And Theatres Act 1968

HOURS OF OPENING

- 1. The licensed premises shall not be kept or used for public music and dancing or other public entertainment of a like kind except between the hours of
 - 9.00am and 12 midnight Mondays to Saturdays.
- 2. The licensed premises shall not be kept or used for public music and dancing or other entertainment of a like kind on Sundays, Christmas Day or Good Friday.

MAXIMUM CAPACITY

3. The maximum capacity of the licensed premises is 150 persons and shall not be exceeded.

EXITS

- 4. The premises shall be provided with exits at:
- 1. 1 x 1200mm double doors to entrance lobby then by 1 x 1200mm double doors to open air
- 2. 1 x 900mm door to open air at both sides of stage

FIRE PRECAUTIONS

- 5. The following fire appliances shall be provided:
- 2 x 9 litre water extinguishers in main hall
- 1 x 2.2 CO2 in main hall
